Local Departure Taxes: Not included. If applicable, passengers must pay locally per destination

IMPORTANT: VALID CANADIAN PASSPORTS ARE REQUIRED AND MUST BE VALID FOR THE ENTIRE DURATION OF YOUR TRIP. PASSPORTS MUST BE IN EXCELLENT CONDITION.

TERMS & CONDITIONS

Please note - due to the numerous parties associated with these packages, the cancellation/change rules from either Tour Operator (Air Canada Vacations), Agency (LATravel Group Inc) or Hotel (Planet Hollywood Cancun) which are most strict will apply.

Payment:

Full payment on your group booking is due March 24th, 2022; changes/cancellations made between March 17th, 2022, and date of departure will be subject to the applicable penalties by the hotel (see below for further details). Group bookings not paid in full by this date may be cancelled and subject to applicable penalties. The below terms and conditions have been slightly amended to match with the terms and conditions of Planet Hollywood Cancun which supersedes the Air Canada Vacations Groups terms and conditions. **Please ensure you are aware of the below change/cancel policy.**

Cancellation:

Cancellations received:

- Booking date to 31-March-2022: loss of deposit.
- 30-March-2022 to 16-May-2022: \$50% penalty of total price per person including any fees & surcharges.
- 15-May-2022 – date of departure 20 days: 100% penalty of total price per person including any fees & surcharges.

*No-shows and early departures from destination are NON-REFUNDABLE

*All cancellations and changes must be made directly with your lead agent and will be processed once all parties included on the file are aware of the cancellation terms and any applicable fees and rate changes incurred.

Name Changes / Document Re-Issue:

- Booking date to 17-March-2022: Change (Name and other changes) are penalty-free unless documents have been issued. \$150.00 per person administration fee will be charged to have documents re-issued.
- 16-March-2022 – 08-June-2022: Change (Name and other changes) are subject to a \$50.00 per person administration fee per change. An additional \$150.00 per person administration fee will be charged to have documents re-issued.
- 09-June-2022 – 23-June-2022: Change (Name and other changes) or if documents are re-issued are subject to a \$250.00 per person administration fee per change
- 22-June-2022 – 25-June-2022: Change (Name and other changes) or if documents are re-issued are subject to a \$350.00 per person administration fee per change.
- 26-June-2022 – 29-June-2022: No changes permitted within 3 days of group departure

*All changes are only permitted if hotel approves

*All changes will only be processed once all parties included on the file are aware of these changes and applicable fees and rate changes.

IMPORTANT NOTES:

- **No changes are permitted within 3 days prior to departure.**
- **Occupancy changes:** 90-0 days prior to departure – Any changes in room occupancies will be on request and may NOT be permitted. For example: rooms will be charged as double occupancy, as originally contracted, even if only one (1) adult is occupying the room. Maximum 20% of the rooms may be booked as SGL rooms. If more, a supplement will apply for any additional SGL rooms booked on file.
- **Changes of departure date or return date:** Free if 90 days or more prior to departure for up to 20% of the size of the group, any passenger beyond, CAD\$250.00 administration fee applies per change. Usual cancellation fees apply to changes made within 20 days prior to departure.
- **Changes are not permitted after departure. If any change is absolutely necessary after departure, request must be directed to Air Canada Vacations destination representative for assistance. Additional fees will apply.**
- **Any guests not paid at final payment due date may be cancelled and any applicable late & cancellation fees will apply. Unreconciled files may hold up travel documents** (For group files – the group leader (i.e., bride & groom) must be aware that if any files have any balances the group travel documents will not be issued)

- **Group Seating and Check-in** – Air Canada Vacations offers advance seat selections to groups, subject to availability for a fee of \$10.00 round trip per person. Book seats for any group may be altered at any time prior to departure at the airline's discretion. Although seats are blocked in bulk and seat numbers are assigned, final assignment is subject to change up until the date of departure during airport check-in. Seat selection becomes free of charge 24 hours to 60 minutes before scheduled departure when using web, mobile or kiosk check in. Group guests are able to use the self-serve web, mobile or kiosks (select airports only) for check in.
- **Schedule Changes** – Air Canada reserve the right for any aircraft or schedule changes any time prior to departure. These changes include day of service, direct flights and full cancellation of flights at any time between now and departure date.

[Booking with the Wedding Group vs Individually Online or with Another Agency](#)

1. Individual bookings made online or with another agency will not be available for everyone in a group. These rates are based on a live inventory system whereas seats and rooms are purchased, the fare increases. These rates are only available for a small number of seats and rooms. Therefore, the people who are last to book may end up losing the most by having to pay the larger package amount.
2. The hotel may charge for the reception for anyone who is not booked inside the group (reception charge could be anywhere from 90 to 150 USD per person for dinner).
3. Amenities and cocktail events are for group guests only- outside guests may have to pay an admission fee or day pass (subject to the hotel).
4. Booking outside the group will not count towards Wedding Couples incentives given by the Travel Agency, Airline or Hotel wedding package.
5. Individual bookings would not partake in any hotel credits and added features are for group guests only i.e.- blocked seats, area at the hotel, rooms close together, private check-in upon hotel arrival (subject to the hotel).
6. If there is a flight change, the group will be looked after wholly and will be the first to be accommodated as one large file. Individual packaged guests who booked outside of the group will be responsible on their own and will be accommodated once the larger group has been looked after. This would be the same for weather delays, cancellations and over-bookings. Individual packaged guests booked outside of the group are placed into a queue.
7. In the case that the host resort has been oversold the same conditions as #6 will apply. Groups will be accommodated first, and Tour Operators reserve the right to move individual bookings to a different property.

These are just a few of the differences between an individual package booked online or another agency versus booking within the Bride & Grooms group booking. The final decision on how you attend the wedding is your choice.
